1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £850.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Basis for qualification

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is inconsistent with the Council's governance arrangements in the year:

- The Council has not provided evidence that it supplied its Clerk with a written contract or a written statement of the specified terms of employment as required by S.1 of the Employment Rights Act 1996 (ERA) within two months of starting employment.
- The Council has not provided evidence that it operated PAYE as it is required to do under the Income Tax (Earnings and Pensions) Act 2003.
