- 10. Review of arrangements (including legal agreements) with other local authorities, not-for-profit bodies and businesses
 - Rental agreement with Powys County Council for land in Cwmdu
 - M Pearse noted the rental increase for the land rented. Councillors discussed the position of the allotment society, S Clay suggested that unallocated allotments be brought into the biodiversity plan, if the Council is paying the difference between what the society can afford from their rentals and the new rent from Powys County Council. The Council also paid for the cutting of the hedge, which is also in the budget. The Council would like to continue to support the allotments and will look at the rental costs.

 - Agreement with CSEG the Clerk stated that she had emailed the contact given after the May Ordinary meeting given that it was resolved to state that the contract has ended.
 - Custodian Trustees of Cwmdu Village Hall M Pearse reminded Councillors of the position. The Clerk explained what a Custodian Trustee is and the Council can remain holding the land in trust.

W Forster stated that he had met with the Black Mountains College were interested in the plot and will send a model agreement for use of the land.

The Clerk explained the background to the Charity and the issues that are involved. M Pearse confirmed that the trustees still include previous Councillors, the Clerk confirmed that an Annual Meeting had taken place. P Silk stated that the previous trustees should be written to allow them to step down if they wish and new Trustees should be elected. M Calvin suggested that the Charity should be contacted to see if they wish to change the structure, if it were formalised then the situation could be resolved. Resolved - for the Clerk to write to the previous trustees and then elect new trustees. H Jackson confirmed that the previous situation was that Councillors were de-facto trustees.

The Council recommends that the Trustees are invited to attend a meeting of the Charity to discuss the issue. H Jackson stated that the ideal position would be for Cwmdu Councillors to become trustees.
